Transportation	Walk or bike everywhere, no public transportation	Walk, bike or take public tansit	Own your own car
Technology Access	Cell phone, no computer, no TV	Cell phone, no computer, TV - no cable	Cell phone, home computer, TV with cable
Child Care	Unreliable family member a few times a week, may not be available	Reliable family member or neighbor, three times a week	All week full service childcare, during work hours
Utilities	Skip this month's bill, face disconnected services	On a payment plan	Pay for all utilities
