

LIHEAP and Utility Assistance Funding Status: Regular & Pandemic-Related Funding March 15, 2021

Released Funds

\$900 million for LIHEAP (CARES Act)

- Released May 8, 2020
- Available through September 30, 2021

\$3.7 Billion of Regular FY 21 LIHEAP Appropriation

- Released November 6, 2020
- 99% of total appropriation (\$3.75 billion total)
- Subject to regular LIHEAP carryover rules

\$25 Billion Rental and Utility Assistance Program (Consolidated Approp. Act of 2021)

- Released: late January, on hold pending additional guidance from Treasury
- New program created as part of COVID-19 emergency response
- Limited to rental households, state determines how much to set aside for utility bills
- Administered by Department of Treasury, state administration varies
- ****Eligibility requirements for utility assistance do not match LIHEAP****
- Available through December 31, 2021

Appropriated Funds Pending Release

\$4.5 Billion Additional for LIHEAP (ARP)

- Passed: March 2021
- In addition to funds already appropriated for LIHEAP
- Funds would be available through September 30, 2022

\$20.25 Billion Additional for Rental Assistance Program (ARP)

- Passed: March 2021
- In addition to funding for rental assistance program described above, for a total of \$45 billion
- Funds would be available through September 30, 2027

Appropriated Funds Pending Release (Continued)

\$1.1 Billion Water Assistance Program (Consolidated Approps. Act and ARP)

- Passed in December 2020 (\$638 million) and March 2021 (\$500 million).
- New program created as part of COVID-19 emergency response
- Administered by HHS, may go through LIHEAP network or CSBG
- Funds available until expended

\$9.96 Billion Homeowner Assistance Fund (ARP)

- Passed: March 2021
- Administered by Treasury to complement rental assistance program
- Limited to owner-occupied households, state determines how much can go towards utility bills
- Funds available through September 30, 2025*
